- B) ESP School Report Steve Paddock, HIA Superintendent
 - a. Great enrollment of 718 students. Pre-K is currently lower with more GSRP programs, 650 this year in comparison to 500 last school year. Demographics, 96% Free/Reduced lunch (as Brooke mentioned 100% this year for all students in MI), 9% Special Education students.
 - b. We are back to work and fully staffed. Our school Orientation was held yesterday. Mrs. McGregor and her team placed high priority on our Orientation this year and it was very successful. Board President Jeff Leib requested an invitation for Board members to attend next year's event.
 - c. Wayne County Public evaluation grade star ratings, we received 4 stars out of 5. Our playground keeps us short of the 5th star. The space is not large enough to offer additional resources for our students. We do have new fencing.
 - d. Pilot new breakfast item choices for our students during breakfast. We have chosen a sit down warm nutritous offering for students to enjoy. Our Pre-K breakfast is in a family style setting in their classrooms. With our program breakfast, lunch and after school snack we feed more than 1500 offerings a day.
